**Subject: The 1st Meeting of the APT Preparatory Group for WTDC-17 (APT WTDC17-1)
and the 13th APT Telecommunication and ICT Development Forum (ADF-13)
2 – 5 August 2016, Singapore**

I am pleased to inform you that the Asia-Pacific Telecommunity (APT) will organize the 1st Meeting of the APT Preparatory Group for WTDC-17 (APT WTDC17-1) on 2 August 2016, and the 13th APT Telecommunication and ICT Development Forum (ADF-13) from 3 to 5 August 2016 in Singapore. The events will be hosted by the Infocomm Development Authority of Singapore (IDA).

As for APT WTDC17-1, the main objective of the meeting is to initiate the preparatory process of the APT for the ITU World Telecommunication Development Conference 2017 (WTDC-17). APT WTDC17-1 is expected to conduct the following activities:

- To elect Chairman and Vice-chairmen of the preparatory group;

- To develop working methods and work plan for the preparation of WTDC17; and
- To have preliminary discussion on WTDC17 issues.

With regard to the APT Telecommunication and ICT Development Forum (ADF), the forum has played a unique role in providing a platform for the APT members including governments, regulators, industry players and all other stakeholders to discuss ways for development of telecommunications and ICT. ADF-13 will address the following:

- The Way to Overcome Digital Divide including the issue of Universal Service Funds (USF);
- Stimulating ICT Business and Industry including innovation, startup and SMEs for ICT Applications;
- Best Practices, Experiences, and Challenges in ICT Development within the Region;
- Increasing Access and connectivity, in Particular Rural Areas;
- Outcome and Achievements of the Projects via Extra Budgetary Contributions (EBCs); and
- Facilitating investment of ICT infrastructure and application;

In this regard, I would like to invite high-level representatives from your administration/organization who are currently involved in telecommunication and ICT development to attend these events.
