I regret to inform you that due to some unavoidable circumstances, the Authority for Infocommunications Technology Industry (AITI) of Brunei Darussalam, will not be able to host the meeting as planned from 01 to 05 July 2013. A letter has been received by myself on this regard from the Authority for Info-communications Technology Industry (AITI) of Brunei Darussalam. The letter is attached in Annex.

Considering the importance of the planned time frame of APG activities and other international commitments of the experts involved in the APG, APT Secretariat has decided to hold the meeting on the same dates in Thailand. The 2nd Meeting of the APT Conference Preparatory Group for WRC-15 (APG15-2) $\underline{1^{st}-5^{th}\ July\ 2013}$

We refer to the above mentioned subject.

We regret to inform you that due to an unexpected change in schedule for ASEAN Foreign Minister Meeting that will coincide with the 2nd Meeting of the APT Conference Preparatory Group for WRC-15 (APG15-2), AITI has been advised by the Ministry of Foreign Affairs and Trade to postpone and release all our venue and accommodation arrangements pertaining to APG meeting. AITI has considered a number of alternatives to proceed with the hosting of APG15-2. However, due to the very large number of delegates attending the ASEAN Foreign Minister meeting, we are logistically challenged as Brunei Darussalam has limited number of hotels for accommodation to host two big meetings simultaneously.

After consultation with APT secretariat, it is not feasible to postpone APG15-2 dates as this will disrupt APT's work plan. As such, given the circumstances which are beyond our control, it is with deep regret that we hereby confirm that Brunei Darussalam is no longer able to host APG15-2. We would like to express our sincere apology for the inconvenience caused. We look forward to collaborate and host future APT events.
